SHOW POWER SUPPLY – Compulsory

- Exhibitors / Contractors are required to order mains power supply for the show days.
- Mains power supply will only be activated and energised on the last day of the build-up, a day prior to the show.
- Mains power supply does not come with a Distribution Board; it should be provided by the Exhibitor/Contractor or ordered through GES.
- **At no point should direct mains be shared. Each stand should also have its own mains cable.**
- **No mains cable should be less than 2.5mm 3 core and should always have an earth.**
- **Earth bonding is mandatory, stand power will not be turned on if there is no earth bonding.**
- **Each stand should have its own means of accessible Isolation along with an 30mA RCD.**
- **No contractor will be permitted to connect directly into a venue mains supply at any time.**
- **ELECTRICAL ORDER WILL NOT BE PROCESSED WITHOUT THE COMPLETED GRID PLAN.**



2. All orders must be placed in writing or via Expresso. No services shall be performed unless, GES accepts the order. GES at its sole discretion reserves the right to substitute unavailable items of a similar quality, specification, and performance.
3. All confirmed orders will be processed, and an invoice will be sent within 3-5 working days.
4. Please contact GES if invoice has not been received after 5 working days from date of order.
5. Mains power cable will be located at the discretion of GES, unless otherwise **completed grid plan is submitted**.
6. Any cable relocations onsite due to the incorrect grid plan submitted, will incur a surcharge.
7. Rates are on a rental basis for the duration of the exhibition.
8. Exhibitors will be held responsible for any loss or damage of parts.
9. If stand requires 24-hour continuous power supply, a surcharge of 30% based on the power supply ordered will be imposed.
10. The exhibitor or stand contractor (not GES) is responsible to provide all electrical connections and fittings e.g., lights and plug sockets, and to ensure that all connections are completed within the required timeframe.
11. Water and waste and compressed air are subject to stand position and venue approval.
12. **The full invoice value must be paid in SAR or USD currency immediately.**
13. **All orders received after the deadline date will incur surcharge and subject to item availability.**
